### Subject-matter or genetic resources covered:

1) Analizar la diversidad y el rol de la colonización de hongos micorrícos arbusculares (AM) en Austrocedrus chilensis afectado por Phytophthora austrocedri. 2) Determinar los efectos de P. austrocedri sobre el crecimiento y variables morfométricas de plantines de Austrocedrus chilensis. 3) Analizar el potencial bioprotector del consorcio nativo de especies AM en plántulas de A. chilensis en presencia/ausencia de P. austrocedri. En el marco del proyecto se vienen desarrollando múltiples actividades, como la detección de P. austrocedri y otras especies de Phytophthora co-habitantes en suelos de bosques sanos y afectados mediante métodos moleculares, el aislamiento de microorganismos y la determinación de su posible actividad biocontroladora, entre otras. En esta instancia queremos avanzar más profundamente en la comprensión de la microbiota presente en el suelo a fin de inferir características de sitio, y predisposición a la enfermedad, así como detectar posibles fuentes de microorganismos protectores. Esto contribuiría a generar información en la temática planteada.
